#### THE PROBLEM:


Erratic water flows in the Upper Farmington River detract from aquatic life, fishing, recreation and businesses, with no authoritative organized approach to address it.

#### **BACKGROUND**

#### **ROLE PLAYERS**

- U.S. Army Corps of Engineers (USACE)
  - -"Owns and maintains Colebrook River Dam
  - -Manages flood control on Farmington River"
- Metropolitan District Commission (MDC)
   "Makes flow releases as required"
- Dept. of Energy & Environmental Protection
   (DEEP)
- "Manages fisheries pool storage and release"

#### 2016 - 2022

- 2016 drought
- 2019: 50<sup>th</sup> year of Colebrook River agreement
- Jun. Sep. 2022: sustained low water levels
- Jun. 14, 2022: MDC files w/DPH for declaratory ruling

- Jan 5: MDC withdraws app. w/DPH mid-hearing
- Jan. 12: House Bill 5214 filed
- Mar. 10: Public Hearing for HB 5214



#### **MID 2023**

- Apr. 20: MDC files abandonment application with DPH for 10 BG
- Early Jul.: the floodgates of the sky were opened
- Jul. 18: MDC announces agreement with NCLC for conservation easement
- Jul. 20: DPH grants abandonment of I0 BG

#### INSTREAM FLOW STUDY

#### **Summary or description of proposed legislation** (what will the bill do?):

That DEEP be directed to oversee an update to the Farmington River Instream Flow Study last completed in 1992, which is linked here:

#### **Statement of Purpose** (What is the reason for the bill?):

To provide information to determine the best flow regime for the Upper Farmington River to support its ecological health and recreational flows in light of changes in climate, as well as recent changes to state and pending changes to federal regulations governing the water in Colebrook River Reservoir.

#### MDC RELEASES

#### Summary or description of proposed legislation (what will the bill do?):

That the Metropolitan District Commission shall make requests for releases from the Colebrook River Dam, as necessary, to maintain the flow of water in the West Branch of the Farmington River at or above a rate determined to be a sufficient minimum flow rate by the Commissioner of Energy and Environmental Protection.

#### **Statement of Purpose** (What is the reason for the bill?):

To require the MDC to make requests for releases from the Colebrook River Dam, as necessary, to maintain the flow of water in the West Branch of the Farmington River at or above a rate determined to be a sufficient minimum flow rate by DEEP.

## SOME FINAL THOUGHTS

- DEEP Office of Outdoor Industry and Experiences
  - Request for Information
    - Ex. Tubing at Satan's Kingdom State Park
- This can't be just about trout fishing, i.e. businesses, local gov't, conservation orgs., sportsman orgs.
- Approach must be multi-pronged legislation and negotiation
- Proposed legislation keeps flow issue on front burner

#### CONCLUSION

- Nature is not entirely predictable, but an updated Instream Flow Study will help
- I0 BG gallon pool in Colebrook River Reservoir cannot be left to just U.S. government flood control interests
- Continuous proactive engagement from all stakeholders will get us closer to a solution to the erratic flow issue
